

## Tarlton Expands into the East Bay with Acquisition of Four Life Science Buildings in Hayward

Tarlton will lease back the properties to current owner Impax/Amneal Pharmaceuticals while Impax/Amneal winds down operations at the site and Tarlton obtains permits to modernize the exteriors and convert the four buildings into a multi-tenant life science campus.
